# The Flea Market at the Corn Feed 14 X 14 Booth Outdoor Space: \$40.00

**Cancellations:** To cancel your reservation you must call (701) 425-2080. *The cancellation deadline is 4 p.m. on August 3* to qualify for a refund.

**Electricity:** There is no power source available at the Flea Market. Gas generators are not permitted.

**Merchandise Excluded:** Food, beverages, alcohol, tobacco products, e-cigarettes, any nicotine delivery system, firearms, ammunition and used clothing less than 20 years old.

**Merchandise & Weather Protection:** The Flea Market at Buckstop Junction's Corn Feed will only close for severe weather. Your booth rental includes the space only; you are encouraged to protect your own merchandise.

**NO Smoking, Pets or Coolers:** Smoking is not allowed on the grounds of Buckstop Junction or within 20 feet of the perimeter fence or the Visitor Center. Pets are not allowed on the grounds during events or while preparing for the event. Please make arrangements to keep your pet safe, do not leave them in your car or tied to your car.

**Parking:** Parking is available outside the east gate of the Buckstop Junction in designated areas. Vehicles are not allowed on the grounds during events. No overnight camping is allowed.

**Portable Merchandise Only:** This is a cash and carry market; only items that can be carried out through the Visitor Center may be sold. The gates will not be opened.

**Set-Up:** Set up is Friday night 5 pm to 7 pm and Saturday between 7am and 9am. All vendor vehicles will need to be moved to a designated area by 8:30 a.m.

**Your Space:** Space only is provided; you must provide any tables, canopy and other furnishings you require for your booth. Concessions, rest rooms and portable toilets will be available.
